

Board of Health

Meeting Minutes

January 4, 2012

Present: Rebecca Allen, Elizabeth Nichols, John Doherty and Jenna Day.

Meeting convened 6:00.

1. Minutes from the December 21st meeting were approved with revisions.
2. Becky signed temporary occupancy permits and a hauler's permit for Bostley Sanitary Services.
3. The Board has heard nothing further from Dorene Hanley regarding the inspection at 159 Number Nine Road. The final inspection is currently scheduled for January 12th.
4. The Board has not yet received sieve analyses for the new septic system at 44 Hosmer Road.
5. Becky is continuing to request a fee schedule for health agent services to be offered by the Greenfield Department of Health. FRCOG did not receive the regionalization grant, so it is possible that the contract for health agent services could renew. The Board needs to contact Phoebe Walker prior to April 1st if we want to withdraw from the contract.
6. Becky will enquire whether Claire Rabbitt was able to submit the application for a Medicare provider number.
7. Letters were mailed to 24 property owners requesting that they obtain temporary occupancy permits and/ or address various code violations at their properties. Three recipients responded and Karen has spoken with them. Letters were received from Donald Scagel (7 Papoose Lake Dr.) and Marjorie Dunham (Syriac) (166 Colrain Stage Road). John will prepare a list of items that need to be removed from the Scagel property. Betty will contact Marjorie Dunham to let her know that performing the clean up next summer will be acceptable to the Board. Don and Angela Rodrigues of 10 Swamp Road have sold their property. The letter addressed to them will be sent to the new owner.
8. The Board approved a letter to John Doherty of 14 Mohawk Beach Drive regarding his failure to respond to an Order to Correct.
9. Betty will contact Bruce LaMothe to see if he can be added to the list of people willing to remove derelict camper trailers.
10. The Board received an email regarding HHAN. Becky says the Board is compliant because both she and Claire are on the notification list.
11. Becky noted that she was informed by the property owner that there were issues with the placement of the septic tank at 96 Taylor Brook Road. There has been no communication from either the installer or designer.
12. The Board approved a well drilling permit for Patrick Martone's property, Lot 2, Underwood Hill Road.
